Limited Review Report

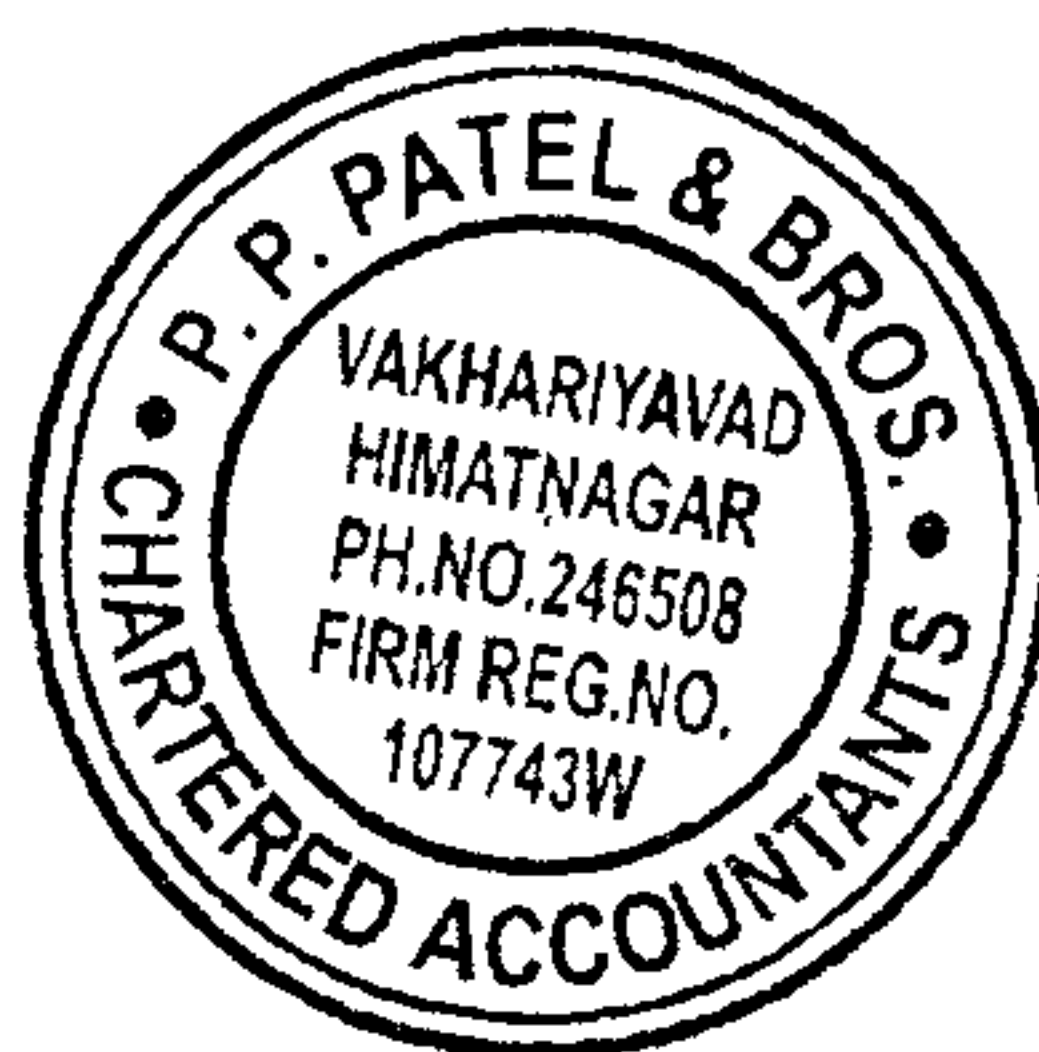
