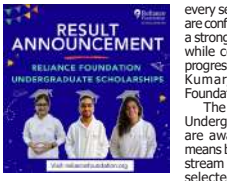

PMLA case against Kiran Patel: ED searches 12 sites

AHMEDABAD: The Enforcement Directorate (ED) on Saturday carried out searches on 12 premises in Gujarat at the locations including Ahmedabad, Gandhinagar, Morbi and Mehsana after Kiran Patel, who claimed to be a high-ranking official with the PMO, was booked under provisions of

Prevention of Money Laundering Act (PMLA). Patel is already facing several charges in Jammu & Kashmir (J&K) and Gujarat for cheating and breach of trust. The agency in a statement said that the searches resulted in the seizure of documents related to immovable properties along with highly

incriminating material. "Further investigation in respect of his activities in J&K and other places is in progress," it said. The searches are conducted by the Srinagar zone office. The locations are associated to five other individuals - Jay Sitapara, Hardik Chandana, Vithhal Patel, Amit Pandya, and Piyush Yasita - who are suspected to be associated with Patel. Patel was caught by Jammu & Kashmir Police in March for posing as additional director of strategies and campaigns at the PM Office. The same case is the basis for the ED action. "By resorting to cheating, forgery and impersonation, he has duped gullible people and also intentionally induced people to do and also to omit to do activities, under a well-knit plan for securing money as well as material benefits," mentioned the ED statement. After a custody with Gujarat Police in April, Patel was sent back to Jammu & Kashmir after the remand had got over, said officials.

Court begins inquiry into Yadav's remark on Gujaratis



AHMEDABAD: A metropolitan court here on Saturday began its inquiry and recorded the statements of three witnesses, over a criminal defamation complaint filed against Bihar deputy chief minister Tejashwi Yadav for his alleged remark, "Looking at the present condition of the country, only Gujaratis can be

Tank from Bhuj in Kutch district. Tank said he was shocked to see Yadav's statement on the YouTube channel of a private news channel.

He said that Gujaratis are spread across many countries and their sentiments are hurt, and he is getting calls from people from all over in this regard. He also said that Gujarati people are settled outside the state, and may be in business activities. The comment by Yadav can cause damage to their businesses. Two other witnesses echoed these sentiments after saying that they saw Yadav's video. The court was also told that after the broadcast of Yadav's statement, the Chhattisgarh Gujarati Samaj filed a complaint in this regard. After the deposition of these three witnesses, Mehta filed an application requesting the court to issue witness summons to the editor of the private news channel and direct him to bring the original records before the court so that it can be verified whether the electronic evidence was tampered with and the necessary certificate can be obtained for admissibility of evidence.

The court instituted the inquiry under Section 202 of the Criminal Procedure Code (CrPC). Three witnesses turned up and gave statements to the court in support of the complaint, which was filed by one Harsh Mehta, a representative of an NGO called "All India Anti-Corruption and Crime Preventive Council".

Rajkot: Bhavnagar police on Sunday lodged an FIR against the second-year MD student for allegedly sodomizing an MBBS student in the hostel of Government Medical College, Bhavnagar. The accused has been identified as Dr. H B Mehta.

The accused, who is also a resident doctor at Sir T General Hospital in Bhavnagar, was booked under Sections 377 and 506 of the Indian Penal Code (IPC) and also under different sections of the SC/ST (Prevention of Atrocities) Act.

The probe into the case was handed over to an officer of the rank of deputy superintendent of police. Sources said that the police have recorded the statements of the victim and the accused. Medical college dean Dr H B Mehta told TOI, "We have constituted a probe committee to investigate the case."
