

For oceans to behave well, humans need to act responsibly

5th November is observed as the World Tsunami Awareness Day to raise awareness for early warnings and actions to protect people, save lives, and prevent the hazard from becoming a disaster. The word "tsunami" comprises the Japanese words "tsu" (meaning harbour) and "nami" (meaning wave). A tsunami is a series of enormous waves created by an underwater disturbance usually associated with earthquakes occurring below or near the ocean. A tsunami is a kind of natural disaster which is caused due to volcanic eruptions in the ocean beds. Tsunamis are natural occurrences in which a series of powerful waves cause a

surge in water that can reach heights of several metres. Tsunamis occur primarily in areas where two continents meet. Tsunamis also happen due to volcanic eruptions under the ocean beds. The Pacific Ocean is well-known for the frequent occurrence of tsunamis. Tsunamis cause a lot of damage to the environment. It destroys the buildings, forests, livelihood, etc. Since it is a sudden event, no one can anticipate its occurrence. Tsunamis are rare events but can be extremely deadly. In the past 100 years, 58 of them have claimed more than 260,000 lives, or an average of 4,600 per disaster, surpassing any other natural hazard. Due to the tsunami, strong look like walls of water can attack the shoreline and be dangerous for hours, with waves coming every 5 to 60 minutes. Tsunami is defined as a sequence of ocean waves with a very long wavelength. Due to the tsunami, strong waves of water are created and move landwards. As a result, there is a large inland water movement that lasts for a long time. As a result, these waves have a significant destructive power. Like any

other natural disaster, tsunamis bring massive destruction to the environment. The leading cause of a tsunami is attributable to an earthquake. However, even volcanic eruptions, landslides and comets or other heavenly bodies hitting the sea can be a source. Japan is the country which has recorded the most significant number of tsunamis. The tsunami generated in the Indian Ocean in the year 2004 is still considered as the most upsetting tsunami taking more than two hundred thousand lives. Tsunamis are quite rare in occurrence as compared to other natural disasters, but they are equally damaging. During the eruption of a volcano on land, debris falls with a great thrust into the water body, causing the same ripple effect. Volcanoes can be underwater as well. All earthquakes do not cause tsunamis. There are four conditions necessary for an earthquake to cause a tsunami: The earthquake must occur beneath the ocean or cause material to slide into the ocean. The earthquake must be strong, at least

magnitude 6.5 on the Richter Scale. The earthquake must rupture the Earth's surface and it must occur at shallow depth - less than 70km below the surface of the Earth. The earthquake must cause vertical movement of the sea floor. The saddest effect of a tsunami is the loss of lives in huge numbers. Tsunamis hit suddenly, with almost no warning and hence people get no time to escape or run away. They drown, collapse, are electrocuted, etc. Tsunamis not only cause massive destruction of life but also degrade the environment in a gigantic way. In order to prevent tsunamis, the government can invest in building strong and high protective infrastructure which can withstand the force of a tsunami. The length should be so tall, that the most upper wave of the tsunami cannot over top it. Plot on Ambli road sells for Rs 3 lakh per square yard



AHMEDABAD: In what is pegged as the most expensive land deal in Ahmedabad, a plot along the posh Iskon-Ambli road was acquired at a record rate of Rs 3 lakh per square yard. Ahmedabad-based developer Sanghavi Realty purchased the 5,400-sqare yard plot for an estimated Rs 160 crore for a commercial project, according to sources privy to the development.

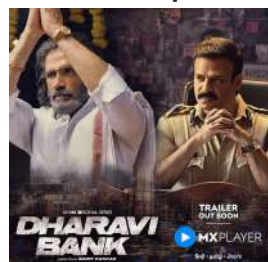
The plot was owned by the family of a city-based entrepreneur who passed away recently. Siddharth Sanghavi, the promoter of Sanghavi Realty, however, remained tight-lipped about the deal. By far, this is pegged to be the costliest land deal in Ahmedabad, the previous best being the sale of a plot near Rajpath Club for Rs 2.95 lakh per square yard. In the past year-and-a-half alone, Iskon-Ambli Road has seen land deals worth at least Rs 2,000 crore.

Morbi municipality's chief officer suspended

MORBI: In the wake of the bridge collapse incident that claimed 135 lives, the Gujarat government has suspended Morbi municipality's chief officer Sandipsinh Zala. The British-era suspension bridge, built on the river Machchu in Morbi town, had collapsed on Sunday evening. The people who died in the tragedy included women and children.

"The state urban development department has suspended chief officer of Morbi municipality Sandipsinh Zala," said Morbi district collector G.T. Pandya. Resident additional collector of Morbi has been given the additional charge of the chief officer until further orders, he said. Police have so far arrested nine persons in connection with the bridge collapse incident.
